PRESIDENT'S REPORT

This season, after a long absence, Bowls New Zealand selected an Over 60s New Zealand team to compete against Australia as part of the Trans-Tasman series along with a Development team and the Blackjacks. Whilst results were mixed, I had the pleasure of presenting New Zealand "Caps" to the Over 60 and Development players at a ceremony on the Gold Coast. It certainly was an emotionally charged event especially for some of the over 60's. Going forward I hope this becomes a regular feature of our international calendar.

Congratulations also to Chris Le Lievre and Sheldon Bagrie-Howley, who became Blackjacks 112 and 113 respectively during the 2019/2020 season.

The profile of the sport was enhanced through the Sky Sport live coverage of the Bowls3Five League. This coverage highlighted our sports diversity and inclusiveness, through the involvement of the Parajacks and others. The in-house produced live-

streaming of our national and international events further amplified our profile and congratulations need to go to the broadcast and commentary teams who delivered this coverage.

Unfortunately, Covid-19 resulted in a number of national and international events being either cancelled or postponed. The main casualties were the World Bowls Championships on the Gold Coast and the Disabled World Bowls in Christchurch. I am aware that Mark Cameron is working with his team and others to see where some of these events can be reinstated. It is disappointing given that these events could have been the highlight of respective bowling careers.

Finally, I am pleased to be part of a team led by Tony Lepper (Chair) and Mark Cameron (CEO) that is resolutely determined to take a leading and productive role in supporting our membership wherever it is practically possible for us to do so.

STAY STRONG - STAY SAFE and together and united we will triumph and in doing so emerge stronger and closer than ever before.

CHAIRMAN'S REPORT

Tony Lepper ONZM



It is with pleasure that I present to you my third chairman's report. As the old rugby adage goes it has certainly been a "game of two halves." Like everyone else in New Zealand the year will be split into life before Covid-19 and some other version of life during and after the global pandemic. In an extremely short period of time we went from planning and preparing for all our key national and international competitions to advising clubs to lock their doors and to abandon their greens. Stay home, save lives became the catch phrase and that meant the end of the Bowls 2019 / 2020 season. With the arrival of Covid-19 New Zealand was plunged into the biggest period of uncertainty any of us have experienced in our lifetimes. What comes out the other side is still not clear but the Board and staff of Bowls NZ will be there to ensure that Bowls as a sport plays a part in the social recovery of New Zealand.

Thanks must go to CEO Mark Cameron whose timing of decision making in the lead up to the various levels of alert was impeccable. Bowls New Zealand fully understands the demographic make-up of our players and we took a predictable cautious approach to exposing our members to the Covid-19 virus. At times it may have seemed that we were being overly cautious but as events unfolded all our decisions were proven to be timely and appropriate. To the best of our knowledge our members were not unnecessarily exposed to the virus and no clusters grew out of our bowling events. In short the health of our members was more important to us than bowls. Thank you to our members who took our advice seriously, restricted their travel, closed down their clubs and kept their members safe.

As we moved through the various stages of lockdown our staff remained busy and focused. We had an early win when sensible advocacy got our greenkeepers back into action in week three of the level four lockdown. Any longer delay could have been disastrous for our clubs and it was very pleasing to see sports working together to come up with common sense solutions. It was also pleasing to see the smooth transition from staff working in an office situation to working from home. As a Chair who has a 2 minute commute to work I worry about the amount of travel required by

staff getting to and from the office. That problem got solved overnight back in March and I expect permanent changes in the working environment will come out of these learnings.

Special thanks must also go to Sport NZ, HPSNZ and their Boards. They quickly realised that these were exceptional times. The rules around our funding were quickly changed and we were largely given the discretion to use our funding for the good of the game as defined by us. Additional funding was also added to the general sport budget and it is our hope that Bowls will get its fair share of this money. We remain of the opinion that no one knows our sport better than we do (Bowls NZ) and some of the bureaucracy around how this funding should be allocated could have been eliminated by dealing with an NSO like us directly. It is extremely heartening that Sport NZ and our government understand the important role sport plays in the general wellbeing of our communities.

Pre Covid-19 seems like a lifetime away. Prior to the outbreak of the virus Bowls NZ and our sport were tracking extremely well. Bowls3Five had its second airing on Sky Sport and once again it was well received by the viewing public and participants. The addition of the Parajacks and the diversity of players involved with the various teams was a highlight for me. Having one of my local players involved with the Parajacks brought home the significance of this competition. It is a very big commitment by all the players but they relish the challenge, take it seriously and grow as people as they progress through the various stages of competition. Many thanks to Erin and her crew and of course the New Lynn bowling club for staging this event and making it all look so very simple.

Year two of Bowls3Five showed a significant acceptance of this format throughout the country with most clubs and centres having some version of this format available. Clubs understand that there is a need to showcase a short form and fun version of Bowls. While competitive bowls is important, social membership of our clubs is equally as important. Bowling clubs can play an important part in the reinvigoration of New

Zealand. Bowls is an affordable and enjoyable sport that has something to offer all New Zealanders. I have always been an advocate for ripping down the fences and showing the public how much fun bowls can be. All clubs need to be thinking of ways to get people to come through their doors and on to their greens.

Bowls NZ has been looking for a new home for some time now and the Board has always thought that it was a "no-brainer" that we should be housed within a bowling club. If Covid-19 had not come along we would be in our new home. I expect that by the time the AGM comes around we will be settling into our new home at the Ponsonby Bowling Club.

All bowlers have been affected by Covid-19 but none more so than our representative teams. Our revamped High Performance program was hitting top gear as we built towards the World Champs in the Gold Coast. Unfortunately the World Champs and some of our end of season New Zealand events coincided with the restrictions put in place around the pandemic. Most events have only been

postponed for a year but it is frustrating for our athletes who were peaking towards the highlight of their bowling careers, when these events were put on hold.

Another event affected by the pandemic was the Disabled World Bowls (IBD) Championships which were being held in Christchurch this November. Bowls NZ was looking forward to highlighting the talent of our disabled bowling community and we remain committed to these valuable members of our bowling community.

The Board of Bowls NZ was pleased to get the new affiliation / levy through the Annual General Meeting and introduced for the 2020/2021 season. We believe that it gives all clubs greater scope to create a more flexible membership structure and that it will encourage clubs to sign up more members. The club census carried out by Bowls NZ staff late last year confirms that our membership numbers are going in the right direction.

Mark Cameron is a committed CEO who has organised a professional team around him that is functioning to a very high standard. Not only is the work getting done but innovation is constantly being explored, tested and implemented. Bowls NZ was well positioned going into Covid-19 both financially and structurally and Mark very quickly began exploring ways of using these strengths for the betterment of Bowls in New Zealand.

As we leave this season behind us we look forward to the challenges that we know we will face moving forward. I believe that we have the team at Bowls NZ to take on these challenges and prosper. I have always believed that financial reserves are there for a reason, they are there for that rainy day when the unexpected happens. In March 2020 the unexpected did happen and it is our job to judiciously use some of those reserves for the benefit of our sport and members.

CEO'S REPORT

Mark Cameron



It has been a pleasure to support the bowls community over the past 12 months, as we first 'almost' completed another summer of bowls within our communities, and latterly managed an extraordinary period with the Covid-19 pandemic.

New Zealand in 2020 will be remembered for phrases such as "Lockdown", "Alert Levels" and "Bubbles"; such was the unprecedented impact Covid-19 has had on our communities, family and lives. Our thoughts go out to those families that lost loved ones, those that saw their business' fail and employment impacted. Whilst there is still a long way to go as the New Zealand economy and communities recover, it is heartening to see New Zealanders placing the health of others ahead of their own material interests.

I am equally proud of how the bowls community responded to the Covid-19 guidelines established by the government and endorsed by Bowls New Zealand. On Monday 16th March, a few days before the Prime Minister announced we would be going into lockdown, Bowls New Zealand postponed the 2020 National Intercentre. At the time, this was viewed as a 'brave decision' by Bowls New Zealand – an acknowledgement that the Intercentre event was due to commence on the 19th March, just three days later. Fast forward four months and the word 'brave' can now safely be replaced with 'sensible'.

Perhaps as an acknowledgement to the bowls demographic (older, with health issues), our sport and bowling clubs grasped the seriousness of Covid-19 and effectively 'closed the doors' for a period of 2-3 months from the end of March through June 2020. This has come at a cost though – not only lost revenues for the clubs, but also the impact it has had on mental and physical health (wellbeing) within our communities.

My thanks to every single bowling club (committees and membership) for supporting the country during 2020 and our response to the Covid-19 pandemic.

Numbers – Clubs / Membership and Participation

I am pleased to report that again we have had some reasonable growth in membership and participation numbers across New Zealand. Our December 31, 2019 census saw a small increase in playing membership (from 24,154 to 25,182) and a big increase in casual participation numbers (from 99,578 to 113,326).

The changes made in the 2019 Bowls New Zealand AGM, whereby a club will now pay a fixed affiliation fee instead of individual membership levies, has undoubtedly contributed to this growth – particularly as clubs feel more comfortable sharing playing and participation numbers with Bowls New Zealand, without fear of being levied for these numbers.

As we move forward, I encourage all bowling clubs to reconsider what your membership offering is to your community – taking advantage of the fact that we have a sport and facilities that are increasingly accessible for ALL New Zealanders. Clubs know their local communities better than Bowls New Zealand, so please let us know how we can assist your club in reshaping your membership.

International Events and High Performance

2020 was meant to be a big year for the Blackjacks and our High Performance programme. However the postponement of the 2020 World Champs to May/June 2021, meant we had a number of frustrated athletes and coaches around the country. A strong performance in the 2019 Asia Pacific was encouraging, however the Trans-Tasman event of February 2020 provided evidence that there is still work to be done if we were going to perform with distinction at the 2021 World Champs in Australia.

Domestic Events and Summer of Bowls

The Summer of Bowls generally starts in October with the Victoria Bowling Club 2-4-2 event and ends in late April with the Bowls3Five Interclub finals. Some 50-60 events are listed in the Summer of Bowls calendar, with a number of events experiencing an increase in entries this past year. My thanks to all those clubs and centres that hosted events – to the participants and ultimately

the winners of these events my congratulations. Special recognition to the Bay of Plenty and Canterbury communities for their support of this year's Summerset Nationals. For the record, this year's nationals saw entries top the 1000 mark, for the first time in a number of years. The inclusion of the Para events in this years Nationals was a particular highlight.

Bowls3Five continued to establish itself on television (Sky Sport) and within bowling clubs in the summer of 2019/2020. Congratulations to the Stoke Thunder for their victory in the televised league, and my personal thanks to members of the Parajacks for making the 2019 Bowls3Five on Sky Sport event memorable. Inclusion of the Parajacks in a national domestic televised event provided further evidence that Bowls is a sport for ALL New Zealanders.

Finances

Despite the impact of Covid-19 Bowls New Zealand was able to record a small surplus for the 2019/2020 financial year of \$39,085. Whilst revenues dropped for the period March to June 2020, this was mitigated by a reduction in expenditure as cost savings were implemented. The postponement of the 2020 World Champs to 2021 also contributed to this improved surplus position.

The full impact of Covid-19 is yet to be seen for the bowls community, as we feel the effects of

lower gaming revenues and sponsorships. Whilst we are optimistic that Covid-19 may not impact membership revenues, it is realistic to assume that a number of clubs in the winter of 2020 will be reconsidering their long term prospects.

Partnerships:

Bowls New Zealand's support of the bowls community would not be possible without an equal amount of support from our funding partners. My sincere thanks to Summerset Retirement Villages and Tower Insurance for your support of our game. Thanks too, Sport New Zealand and High Performance Sport New Zealand these past 12 months – the leadership of Sport NZ throughout the Covid-19 lockdown was exceptional.

Our supply partnerships with Apex Insurance (200+ bowling clubs), Prebble Seeds (300+ bowling clubs) and Dynasty benefit both club and Bowls NZ. Thanks also to Sky Sports for their support over the summer – with 10+ events and over 250 hours screened live on either Sky Sport or Sky Sport Next, Sky has quickly established itself as the new 'home of bowls'.

There were many community partners that supported the sport of bowls this past year. This included the NZCT, Lion Foundation, Canterbury City Council, TTCF and Four Winds. My thanks to these organisations and all those that have supported the bowls community in 2019/2020.

Looking Forward

There are two attributes that I believe our Bowls New Zealand team have made progress on over the past couple of years. They are: our communication with the bowls community and our continued desire to challenge thinking.

Our website and Facebook contain evidence (written and video) of change within our bowls community. Evidence too, is the increasing frequency with which members of the Bowls NZ team are supporting individual bowling clubs on key change initiatives. It is pleasing to see a positive energy within a majority of clubs around the country.

Bowls has historically been described as a sport living in the 20th century. Yet our sport can evidence growth and change through the following:

- Increasing club playing membership
- Increasing casual participation numbers
- New Television League (8 weeks, three nights per week)
- An engaged Facebook membership
- Financially viable
- A new club (not membership) affiliation model
- New commercial partners and revenues
- Increased attendances at National Events
- Quality video streaming of national and international events
- A new 'modern' format for the game (Bowls3Five)
- New capital investment (artificial and covered greens)
- Good governance and strategy

The bowls community is by no means perfect, but to be accused of going backwards in 2020 is something we should all challenge.

Finally, my thanks to all those that have made this past year so successful. This includes the officials at all 478 bowling clubs and 27 bowls centres. My thanks to the Board of Bowls New Zealand (including Tony Lepper ONZM as Chair) for their understanding of sport governance and allowing my team and I to accept that a fail every now and again, just makes our organisation and sport stronger. The confidence and trust you place in the Bowls New Zealand team (Kaushik, Helen, Martin, Chris, Erin, Steve, Alex and others) allows us to be better in the support of our bowls community.

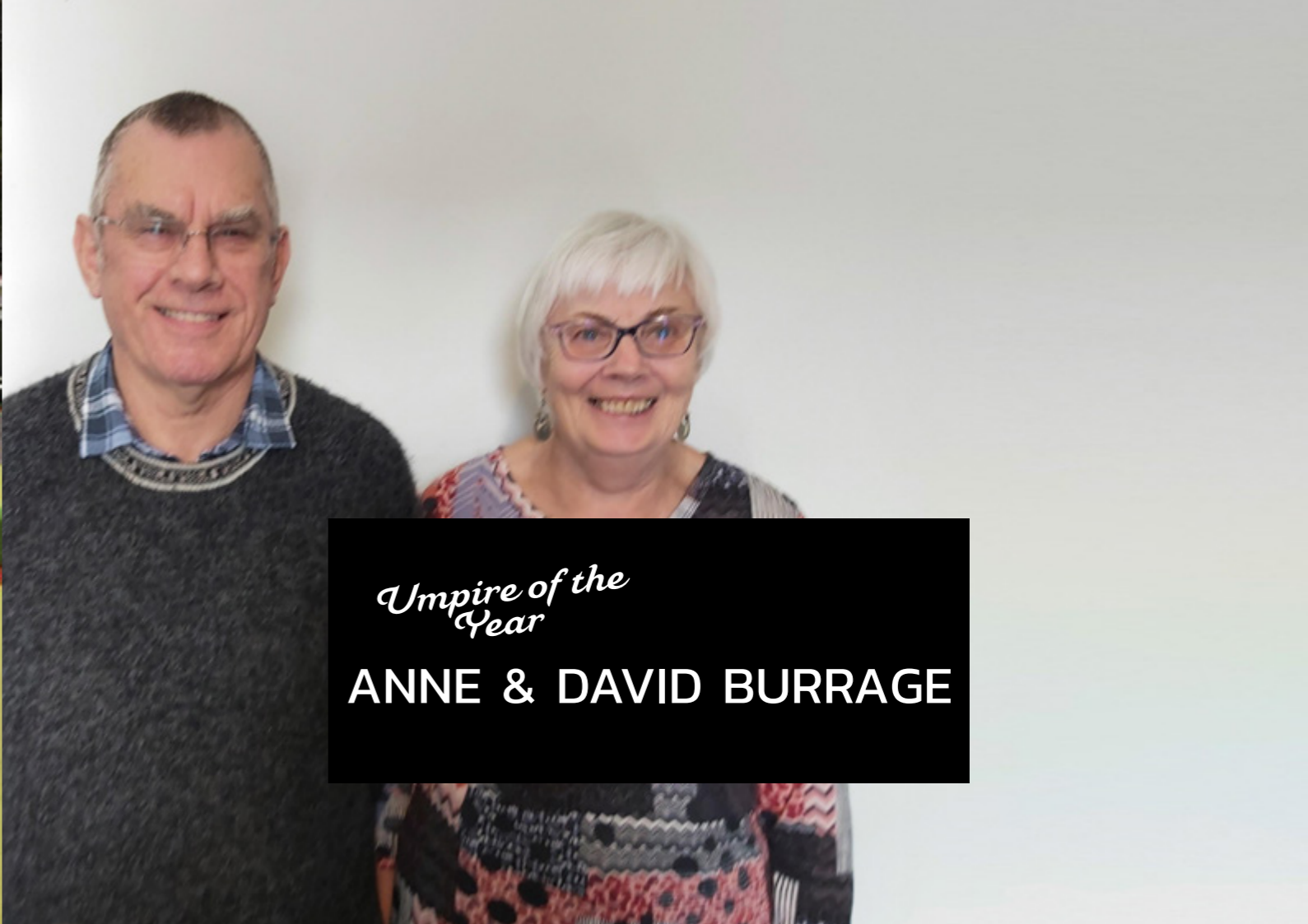

STATEMENT OF ACCOUNTING POLICIES

Bowls New Zealand Incorporated. For the year ended 30 June 2020

1. STATEMENT OF ACCOUNTING POLICIES

BASIS OF PREPARATION

The reporting entity is Bowls New Zealand Incorporated ("Bowls NZ"). Bowls NZ is domiciled in New Zealand and is an incorporated society registered under the Incorporated Societies Act 1908. Bowls NZ as an incorporated society is not required to report under the Public Benefit Entity International Public Sector Accounting Standards ("PBE IPSAS") and other applicable financial reporting standards as appropriate that have been authorised for use by the External Reporting Board for Not-For-Profit entities. However, it has chosen to voluntarily adopt the majority of these standards in the preparation of these special purpose financial statements as it transitions towards full implementation, with the exception of the non-presentation of a cashflow statement and key management personnel disclosures.

Bowls NZ is a public benefit not-for-profit entity and is eligible to apply Tier 2 Not-For-Profit PBE IPSAS standards on the basis that it does not have public accountability and it is not defined as large. The Board has elected to report consistent with Tier 2 Not-For-Profit PBE Accounting Standards with the exception of the above items, and in doing so has taken advantage of all applicable Reduced Disclosure Regime ("RDR") disclosure concessions.

The significant accounting policies used in the preparation of these financial statements are set out below. These financial statements has been prepared on the basis of historical cost, as modified by the fair value measurement of non-derivative financial instruments, and on a going concern basis. All figures presented are in New Zealand dollars.

The board considers that the accounting policies adopted in these special purpose financial statements are appropriate to give the users of the financial statements meaningful information about the performance and position of the organisation for the current year.

SPECIFIC ACCOUNTING POLICIES

(A). REVENUE

Revenue is recognised to the extent that it is probable that the economic benefit will flow to Bowls NZ and revenue can be reliably measured. Revenue is measured at the fair value of the consideration received or receivable. The following specific recognition criteria must be met before revenue is recognised.

REVENUE FROM NON-EXCHANGE TRANSACTIONS

DONATIONS

Donations are recognised as revenue upon receipt and include donations from the general public or donations received for specific programmes. In kind services, including volunteer time are not recorded as revenue or expense.

GRANT REVENUE

Grant revenue includes grants given by charitable organisations, philanthropic organisations and businesses. Grant revenue is recognised when received unless there is a clear use or return condition. In this case, revenue is recognised when the conditions attached to the grant have been complied with. Where there are unfulfilled conditions attaching to the grant, the amount relating to the unfulfilled condition is recognised as a liability and released to revenue as the conditions are fulfilled.

REVENUE FROM EXCHANGE CONTRACTS

SPONSORSHIP INCOME

Funds received from sponsors are recognised as revenue when the terms of the relevant sponsorship agreement have been met.

MEMBERSHIP FEES

Annual fees and subscriptions from bowls clubs are recognised in revenue evenly over the membership period.

EVENT INCOME

Entrance fees for functions and events are deferred initially and recorded as revenue when the function or event takes place. Related expenses are recognised as prepayments until the events occur.

INTEREST AND DIVIDEND INCOME

Interest revenue is recognised as it accrues, using the effective interest method. Dividend income is recognised when the dividend is declared.

(B). FINANCIAL INSTRUMENTS

Financial assets and financial liabilities are recognised when Bowls NZ becomes a party to the contractual provisions of the financial instrument.

Bowls NZ derecognises a financial asset or, where applicable, a part of a financial asset or part of a group of similar financial assets when the rights to receive cash flows from the asset have expired or are waived, or Bowls NZ has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party; and either:

- Bowls NZ has transferred substantially all the risks and rewards of the asset; or
- Bowls NZ has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

FINANCIAL ASSETS

Financial assets within the scope of PBE IPSAS 29 Financial Instruments: Recognition and Measurement are classified as financial assets at fair value through surplus or deficit, loans and receivables, held-to-maturity investments or available-for-sale financial assets. The classifications of the financial assets are determined at initial recognition.

The categorisation determines subsequent measurement and whether any resulting income and expense is recognised in surplus or deficit or in other comprehensive revenue and expense. Bowls NZ's financial assets are classified as either financial assets at fair value through surplus or deficit, or loans and receivables. Bowls NZ's financial assets include: cash and cash equivalents, short-term investments, receivables from non-exchange transactions, receivables from exchange transactions and investments.

FINANCIAL ASSETS AT FAIR VALUE THROUGH SURPLUS OR DEFICIT

Financial assets at fair value through surplus or deficit include items that are either classified as held for trading or that meet certain conditions and are designated at fair value through surplus or deficit upon initial recognition. Bowls NZ's equity investments fall into this category of financial instruments.

LOANS AND RECEIVABLES

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. After initial recognition, these are measured at amortised cost using the effective interest method, less any allowance for impairment. Bowls NZ's cash and cash equivalents, short-term investments, receivables from non-exchange transactions, receivables from exchange transactions and non-equity investments fall into this category of financial instruments.

IMPAIRMENT OF FINANCIAL ASSETS

Bowls NZ assesses at the reporting date whether there is objective evidence that a financial asset or a group of financial assets is impaired. Different criteria to determine impairment are applied for each category of financial assets. Where an impairment is identified, the carrying amount of the asset is reduced and the loss is recognised in the surplus or deficit for the reporting period.

FINANCIAL LIABILITIES

Bowls NZ's financial liabilities include trade and other payables (excluding GST and PAYE), employee entitlements and deferred income (in respect to grants whose conditions are yet to be complied with).

All financial liabilities are initially recognised at fair value (plus transaction cost for financial liabilities not at fair value through surplus or deficit) and are measured subsequently at amortised cost using the effective interest method except for financial liabilities at fair value through surplus or deficit.

(C). CASH AND CASH EQUIVALENTS

Cash and cash equivalents are short term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

(D). SHORT TERM INVESTMENTS

Short term investments comprise term deposits which have a term of greater than three months and less than 12 months and therefore do not fall into the category of cash and cash equivalents.

(E). INVENTORIES

Inventories held are measured at the lower of cost and net realisable value.

(F). PROPERTY, PLANT AND EQUIPMENT

Items of property, plant and equipment are measured at cost less accumulated depreciation and impairment losses. Cost includes expenditure that is directly attributable to the acquisition of the asset. Where an asset is acquired through a non-exchange transaction, its cost is measured at its fair value as at the date of acquisition.

Depreciation is charged on a straight line basis over the useful life of the asset. Depreciation is charged at rates calculated to allocate the cost or valuation of the asset less any estimated residual value over its remaining useful life:

- Building Improvements 17%
- Office Equipment 20% to 67%

Depreciation methods, useful lives and residual values are reviewed at each reporting date and are adjusted if there is a change in the expected pattern of consumption of the future economic benefits or service potential embodied in the asset.

(G). GOODS AND SERVICES TAX (GST)

Revenues, expenses, assets and liabilities are recognised net of the amount of GST except for receivables and payables, which are stated with the amount of GST included. The net amount of GST recoverable from, or payable to, the Inland Revenue Department is included as part of receivables or payables in the statement of financial position.

(H). INCOME TAX

Bowls NZ is wholly exempt from New Zealand income tax having fully complied with all statutory conditions as an amateur sports promoter under section CW 46 of the Income Tax Act 2007.

(I). LEASES

Payments on operating lease agreements, where the lessor retains substantially all the risk and rewards of ownership of an asset, are recognised as an expense on a straight-line basis over the lease term.

Payments on finance lease agreements, where the lessee retains substantially the risk and rewards of ownership of an asset, are capitalised. The asset and the corresponding liability are recorded at inception at the fair value of the leased asset.

Interest charges under finance leases are apportioned over the terms of the respective leases. Capitalised leased assets are depreciated over their expected useful lives in accordance with rates established for similar assets.

(J). EMPLOYEE BENEFITS

Wages, salaries, annual leave and sick leave.

Liabilities for wages and salaries, annual leave and accumulating sick leave are recognised in surplus or deficit during the period in which the employee provided the related services. Liabilities for the associated benefits are measured at the amounts expected to be paid when the liabilities are settled.

(K). SIGNIFICANT ACCOUNTING JUDGEMENTS, ESTIMATES AND ASSUMPTIONS

The preparation of Bowls NZ's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and the accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that require a material adjustment to the carrying amount of assets or liabilities affected in future periods.

JUDGEMENTS

In the process of applying Bowls NZ's accounting policies, management has made the following judgements, which have the most significant effect on the amounts recognised in the financial statements:

OPERATING LEASE COMMITMENTS

Bowls NZ has entered into a number of operating leases.

Bowls NZ has determined, based on an evaluation of the terms and conditions of the arrangements, such as the lease term not constituting a substantial portion of the economic life of the property, that it does not retain all the significant risks and rewards of ownership of these properties and accounts for the contracts as operating leases.

ESTIMATES AND ASSUMPTIONS

There are no key assumptions concerning the future and other key sources of estimation uncertainty at the reporting date, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.
