2022/2023 Business Plan

2023/2024 Business Plan

The CEO was requested to update the document linking projects within the Business Plan to the 2023-2026 Strategic Plan.

4. Risk & Audit Matters

4.1 R&A Report

2022/2023 Provisional EOY Financials

The Board reviewed and approved the provisional results for the Year End 30-June-2022, including:

- Profit & Loss Statement
- Balance Sheet
- Accounts Receivable and Accounts Payable
- Investments

The provisional result was recorded as an EOY deficit of \$217,980, which was approximately \$40,000 improved on the Budgeted Deficit of \$265,920.

2023/2024 Budget

The Board approved a Budgeted Deficit of \$150,642 for the 2023/2024 Financial Year.

This deficit will reduce our cash reserves to approximately \$1.1 million (2017 level) and follows three years of covid-impacted deficits.

The Risk Register and the Health & Safety Register was tabled and reviewed by the Bowls NZ Board.
